Terms and Conditions.

1. The above Rates should be quoted on hourly basis and per day (8 hours) for the hiring of trucks.
2. The bidder should arrange machineries /skilled labours as follows at site and payment to be settled by the firm.
 - a) Driller/Skilled labours for handling of jack hammer/compressor.
 - b) A Blaster for handling blasting materials.

c) All size of drill rods as required at site should be arranged by the firm.

3. The employer shall not accept if the bidder fails to comply one of the above instructions.
4. The **safety equipment** like helmet, hand gloves, boots, first Aids Kits, dress or cloths and other necessary protection against unforeseen calamity at construction site on the expanses of the management should be provided to the working staff or the firm.
5. Machine should be deployed with necessary and sufficient equipment at construction site so that it should not have problems due to requirement of them.
6. This Administration shall not be held responsible if any mishap occurs to machines or labours employed during the period of construction.
7. **The quoted rate must include fuel, insurance, salary of the contractor's staff, salary of skilled and non-skilled labours, to and fro transportation of machine to the work site.**
8. **In the events, if the machine breaks down due to mechanical problems, equipment, fuels, transportation, absent of operator, the Hiring Agency should immediately deploy/ substitute/ replace/ repair/ supply to the staff or construction site.**
9. **Registration Certificate Book with other necessary valid and updated documents of the machinery have to be attached and submit along with the bid, failure to adhere shall be considered non responsive bidder.**
10. **EMD amounting to Nu. 150,000.00/- in form of cash warrant/demand draft/bank guarantee from any financial institution in favor of Dzongdag, Dzongkhag Administration, Lhuentse, must be submitted as per the attached format for the period of One Financial Year, If NOT we will forfeit the amount failing to comply with terms & condition set.**
11. All the staff including machines engaged or deployed by the management for the construction should be **insured as per the requirement till completion of works** and submit the insured documents to the Dzongkhag Administration within 15 days from the date of signing work order to confirm the insurance.
12. **The work should start within 10 days from the date of issuance of work order, failing to respond will led to forfeiture of EMD.**
13. If the progress of the work is held up due to break down of machines for more than **ten days**, the liquidity damage equivalent to the **quotation rate per day** as submitted by the firm shall be deducted from the bill from eleventh day of the breakdown of the machines.

14. The bidder must maintain the log book and record the date, time and months to confirm the work carried out and submit the bill along with a photo copy duly signed by officials nominated by Dzongkhag/Gewog Administration to authenticate the working hours.
15. The bidder shall be informed to remove machine or terminate service at any time upon completion of ordered work.
16. Additional work if requires should be done only upon **getting formal approval** from the concerned authority/work order or else no payment shall be entertained.
17. The bill verified by site engineer and other officials nominated by Dzongkhag/Gewog Administration shall be final and binding.
18. The Tender should reach to PABX Office on 13/07/2020 before 10:00 AM and opening shall be on 13/07/2020 at 10:30 AM in Dzongkhag Conference Hall.
19. The decision of DLTC shall be final and binding.
